Concerning the appointment of the team monitoring the functioning of the University during the SARS- CoV-2 epidemic

Based on Article. 23 clause 1 and item 2 point 2, art. 50 paragraph 1 of the Act of 20 July 2018 - Law on Higher Education and Science (Journal of Laws of 2020, item 85, as amended) and § 28 item 1 i 2, § 29 point 2 of the Statute of the Jan Kochanowski University of Kielce, in connection with the Act of March 2, 2020 on special solutions related to the prevention, prevention and eradication of COVID-19, other infectious diseases and crisis situations caused by them (Journal of Laws of 2020, item 1842 as amended), the following is ordered:

§ 1

A team is appointed to monitor the functioning of the University during the SARS- CoV 2 epidemic (hereinafter referred to as a Team) in the following composition:

§ 2

Tasks of the Team shall include, in particular

- 1. Assessment of the risk involved at the University during the time of epidemic
- 2. Preparing, in reaction to the risk involved, organizational solutions for the University during the time of epidemic, concerning in particular:
 - a) conducting the didactic process
 - b) organizing students' activity
 - c) organizational and administrative activity
 - d) safety rules and hygienic conditions of work
 - e) conducting meetings and taking decisions by the collegiate entities in remote mode
- 3. Constant monitoring of the functioning of University at the time of epidemic and after the epidemic, in particular
 - a) analysing negative consequences for the function of the University in connection with epidemic
 - b) monitoring and observing the procedures outlined in item 2
 - c) updating the procedures mentioned in item 2 to the current law and the present epidemic situation
 - d) preparing analysis and reporting to the Rector on the current functioning of the University at the time of epidemic

§ 3

1. As part of the Team's functioning, the Team shall have the right to inspect the University's documents

2. At the request of the Team Chairperson all organizational units and all people employed and educated at the University may be asked to submit information, explanation, reports and documents concering the functioning of the Team

§ 4

The order enters into force on the day of signing.
